COMPLIANCE AFFIDAVIT OF THE RESPONDENT NO. 9, THE COMMISSIONER OF POLICE, HOWRAH POLICE COMMISSIONERATE IN TERMS OF THE ORDER OF THE NATIONAL GREEN TRIBUNAL, EASTERN ZONE BENCH KOLKATA

I, Shri, Praveen Kumar Tripathi son of Shri Sitaram Tripathi, aged about 49 years, by faith: Hindu, by occupation- Government Service, now posted as Commissioner of Police, Howrah, District: Howrah Pin No. 711101 do hereby solemnly verify and say as follows:-

1. I am the Commissioner of Police, Howrah within the State of West Bengal competent to affirm this affidavit and I have made myself acquainted with the facts and circumstances of this case on behalf of the respondent no. 9.

2. That I have received the server copy of the order dated 10.10.2023 passed in O.A. No. 104/2023/EZ by Hon'ble National Green Tribunal from Shri Sibojyoti Chakraborty, Ld. Counsel for the State.

3. That in the said order, Hon'ble Tribunal in context of the contention of the said Original Application directed the Commissioner of Police, Howrah to file his affidavit showing action taken with respect to the various letters issued by the respondent no. 4 i.e. Estate Manager, Kolkata Port Turst, presently Shyama Prasad Mukherjee Port, Kolkata.

4. That this Affidavit is being affirmed in pursuant to the solemn order passed by the Hon'ble Tribunal on 10.10.2023.





5. That from the present Original Application, it has been revealed that in 2007, the Chief Scientist and Head, Technical Cell, West Bengal Pollution Control Board, vide its Memo No. 1715-4A-2/2007 dated 03.09.2007 passed a shifting order and directed nine numbers of hotels/eateries namely i) M/S. Abhishek Hotel ii) M/S. Dutta Cabin iii) M/S. Sai Ganga Hindu Hotel iv) M/S. Sonkar Hindu Hotel v) M/S. Jay-Bijay Hindu Hotel vi) M/S. Hotel of Sri Dilip Sonkar vii) M/S. Hotel of Sri KailasH Sonkar viii) M/S. Durga Mukesh Hindu Hotel ix) M/S. Islamia Hotel operating at the bank of river Ganga at Chandmari Ghat, Howrah, to shift their activity from their present premises to any other location within six months.

6. That after passing the order by the West Bengal Pollution Control Board, vide its Memo No. 1715-4A-2/2007 dated 03.09.2007 the following letters were received from the respondent no. 4, Shyama Prasad Mukherjee Port authority seeking police assistance for removal of illegal encroachments. The letters were duly forwarded to the concerned Officer-in-Charge of Golabari Police Station for taking action.

7. That in compliance to the order of Hon'ble National Green Tribunal, direction was issued to the Officer-in-charge, Golabari Police Station by the answering respondent vide Memo No. 1575/23/Legal Cell/ M.R. - 196 dated 31.10.2023 and Org. No. 1595/23/Legal Cell/ M.R. - 196 dated 02.11.2023 for taking necessary action. (Annexure - A & B)

8. That Officer-in-charge, Golabari Police Station, submitted his report vide D.R. No. 5308/23 dated 07.12.2023 stating that 12 (twelve) number of hotels are situated at and around Chandmari Ghat opposite to Howrah Railway Station which are being run for more than 50 years. More than 150 persons are employed in those hotels. More than 50,000 (fifty thousand) commuters used to take food from those hotels every day. (Annexure – C)

9. That the effluents and wastes produced by the hotels / eateries are discharged through the pipe lines connected to the nearby underground drainage and finally dumped in river Ganga. In this regard a proper sewerage system and waste management system is required by the competent authority.

10. It has been revealed that since 2015, the respondent no. 4 used to submit one letter every year seeking necessary police assistance for removal of unauthorized hotels situated at Chandmari Ghat opposite to Howrah Railway Station. But no further communication or joint inspection did for executing the order of Hon'ble National Green Tribunal peacefully as informed by the Officer-in-charge, Golabari Police Station. No such inspection or assessment was conducted by the respondent no. 4 involving all stakeholders. There is every chance of cropping up of serious Law and Order issues and breach of peace if the eviction takes place without proper assessment and adequate police deployment at the time of eviction. As there are nine numbers of hotels to be evicted/shifted and livelihood of many people will be affected. Detail planning and huge number of police force will be required for execution of the order.

11. That on 23.11.2023, the Officer-in-charge, Golabari Police Station, Howrah issued a letter to the Asst. Estate Manager & Authorised Officer, Under Public Premises, Shyama Prasad Mukherjee Port, 1st floor, 6, Fairly Place, Vairie Warehouse, Kolkata – 700001 requesting for fixing a date for joint inspection and assessment for eviction of hotels / eateries at Chandmari Ghat, opposite to Howrah Railway Station involving all concerned departments. (Annexure – D)

12. That on 18.12.2023, the Officer-in-charge, Golabari Police Station received a letter from one S.K. Chowdhury, Assistant Estate Manager-Raid, Shyama Prasad Mukherjee Port, Kolkata vide No. Lnd 3163/C/IV/23/3175 regarding holding joint inspection on 22.12.2023 at 12.00 hrs. (Annexure – E)

13. That accordingly, on 22.12.2023, a joint inspection and co-ordination meeting in connection with eviction of hotels at Chandmari Ghat, opposite to Howrah Railway Station was held in presence of all stake holders. During inspection it has been decided that next meeting will be held after the Gangasagar Mela and thereafter date of eviction will be fixed up. The minute of the inspection is annexed herewith marked as Annexure – F.

With due respect I would like to report on the above mentioned matter. There are good number of hotels and eateries near Howrah Railway Station beside the river Hooghly which are the concern subject.

In this regard, Letters were received from the Asst. Estate Manager & Authorized Officer, Syama Prasad Mookerjee Port vide memo No. Lnd/1/22/4751 dated 22.12.2022, letter dated 28.01.2023 in proceeding No. 785 of 2006, letter dated 28.01.2023 in proceeding No. 784 of 2006, memo No. Lnd.3600/IV/23/2601 dated 10.10.2023 in my tenure. Some letters may also be received by this office earlier.

After receiving these letters, preliminary enquiry was conducted. During enquiry it revealed that more than 10(ten) number of hotels are situated at and around Chandmari Ghat opposite to Howrah Railway Station which are being run for at least 50 years and above. More than 150 persons are employed in those hotels. More than 50,000 (fifty thousand) railway passengers and common people use to take food from those hotels every day. During enquiry it revealed that at the time of eviction serious law & order problem can not be ruled out. A strong police arrangement is needed in this scenario.

The effluents which are discharged through the pipe lines connecting the hotels find their way in to the nearby underground drainage lines which directly leads to the river Ganga.

Several letters were issued by the Estate Manager, Kolkata Port Trust / Syama Prasad Mookerjee Port to provide police assistance. Due to different festivals, political and other programmes, police were engaged in huge number of law and order duties. So force can not be provided to the Port Trust authority. Myself sent a letter on 23.11.2023 to the The Asst. Estate Manager, & Authorised Officer, Under Public Premises, Shyama Prasad Mukherjee Port, 1st floor, 6, Fairlie Place, Vairie Warehouse, Kolkata 700001 requesting him to fix a date for joint inspection cum assessment involving the Howrah Municipal Corporation, Howrah Police Commissionerate, other concerned departments and his department. The letter was duly received at the office of the Syama Prasad Mookerjee Port on 23.11.2023. We are ready to provide police assistance after the joint inspection and assessment of the situation.
